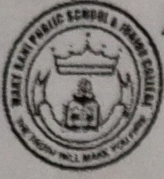

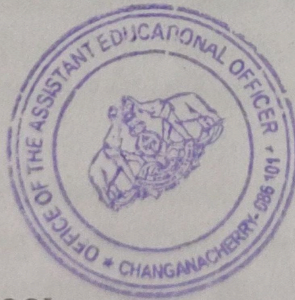

As per the court order we are once again submitting the FORM NO.1 duly filled addressed to Deputy Director along with the copy of NOC and FPRL for your referral.


