



FORM OF AGREEMENT

The articles of agreement executed on the Mary Rani Educational and charitable Trust, Laikade, Changanacherry No.266/IV/'98 hereinafter referred to as the Management on one part and the Education Department, Government of Kerala, hereinafter referred to as the Government on the other part.

Whereas at the request of the Management the Government have agreed to issue a N.O.C to the Management for getting affiliation for the middle class syllabus and provisional affiliation with Central Board of Secondary Education (C.B.S.E) Delhi, for the purpose of enabling students to appear for the examination of C.B.S.E, Delhi and also to certify and to countersign the transfer certificate issued by the Mary Rani Public School, Laikade from time to time on the condition hereinafter appearing to which the management has fully agreed.

Now these present witness and it is hereby agreed as follows:

1. The Management agrees that the inspecting officers of the Education Department of the Government of Kerala or such other officers authorised on this behalf by the Director of Public Instructions, Trivandrum may inspect the said school in order to enable such officers to assess the standard of instruction imparted at the said school.
2. The management shall at any time render all facilities and assistance to the officers mentioned in the preceding clause to conduct the inspections.

3. The Government or any officers of the Education Department authorised by the Government shall issue a NOC for the affiliation of the said school with the C.B.S.E Delhi and also to certify and countersign the T.C issued by the school from time to time on the understanding that the management agrees that the standard of Education imparted at the Mary Rani Public School, Laikade would justify the issue of NOC.
4. Malayalam will be taught from L.K.G classes onwards and Hindi our Rashtra Bhasha will be taught from First Standard.
5. In case the management fails to comply the above said items and conditions, the government will have the right to terminate the agreement.
6. In case of any doubt or dispute arising under or by virtue of this agreement, that the decision of the government thereon shall be final and legally binding on the management.
